Please answer 'yes' or 'no' to each general permission statement.

_____ I will **not** hold Kingston's Camp responsible for any of my child's clothes, possessions, or personal sports equipment. They will be properly labeled and sent with all necessary instructions to keep in their designated areas while at camp.

_____ I will **not** allow my child to bring toys, 'treasures' or sports equipment from home. Personal property not listed on the What to Bring to Camp list (<http://www.kingstonscamp.com/97/what-to-bring>) must be approved in writing by the director.

_____ I understand electronic games, ipods and cell phones are not allowed to be used at camp, and may be removed from the camper's possession until dismissal time.

_____ I have read the financial information (<http://www.kingstonscamp.com/faq>) and agree to all terms.

_____ I have read and understand all camp rules (<http://www.kingstonscamp.com/camper-rules>) and explained them to my child.

_____ I have read about the programs offered and my child may participate in all, except those noted on Medical Form.

_____ I understand that if there are severe weather warnings i.e. hurricane or tornado that camp may be cancelled. I understand that if camp is cancelled an e-mail will be sent out to parents, and I will call to confirm that camp is cancelled[LLI].

_____ I understand if there is an emergency of any kind I will be contacted by phone by camp personnel.

_____ I will call Kingston's Camp if my child will be absent. I understand Camp will NOT call me unless I request that service if my child is biking or getting transportation to camp from another person.

_____ At the beginning of the day I will let camp staff know who is picking my child up that afternoon.

_____ I give my child permission to take short walking field trips off Kingston's Camp's property (e.g. the Bike Path or Genessee Swamp, etc.).

_____ I give my permission to Kingston's Camp to use my child's photograph in promotional material.

_____ I give permission for my child's picture to be posted upon Kingston's Camp's **secure** photo service, and understand that picture may be purchased by myself and/or other campers.
